From I-5, take Exit 88 (Tenino/Aberdeen). Turn west towards Rochester. (Right if coming from the North, Left if coming from the South).

Follow Hwy 12 for about 13 miles to the city of Oakville. In Oakville turn left on State Street.

State Street will turn into S Bank Road. Follow it out to 2009 and the wildlife area. You will see a large Department of Fish & Wildlife sign & should see a lot of cars and motorhomes parked there.

On the day of the test you will need to walk through the green gate at the end of the parking lot to the stand of trees and check in at the scoring table.

1. Remember to bring plenty of water for you and your dog(s). Remember this is Washington so the weather could do anything - be prepared for rain, wind, or even sunshine!!
2. Lunch each day will be available for a nominal fee.
3. Camping overnight is permitted!!
Join us for a potluck dinner Saturday night!
Bring some meat to grill and a dish to share!
4. Master Hunters will not need to bring their own guns – One will be provided for you.
