Directions:

From I-5 North or South, Exit at Exit 88, turn west towards Rochester (or towards the McDonalds)
Drive about 12 miles to the town of Oakville, WA.

Turn Left at the light at State Street. (There's a Post Office on the far left corner, and a bar and a Bank on the right side corners.)

After 2.8 miles State Street Becomes So. Banks Road. Continue on to 2009. It's on the right hand side, you will see a lot of trailers parked in the Parking lot and will see the WA State Dept. of Fish and Wildlife sign.

Park your vehicle, walk back, through the gate, and come check in at the scoring table!
